At the very outset Prof. Tankeshwar Kumar, Vice-Chancellor welcomed Prof. Devendra Mohan, Dean, Faculty of Physical Sciences, Dr. Deepak Kedia, Associate Professor and Sh. Kuldeep Singh, Asstt. Professor nominated on the Executive Council and introduced them with other members.

- **1. Confirmed** the minutes of the 77th meeting held on 18.05.2017 (circulated vide letter no. Acad./AC-II/EC-77/2017/2290-2305 dated 02.06.2017).
- **2. Noted** the follow-up action report on the decisions of the 77th meeting held on 18-05-2017 (Annexure-1 Pages 3-35 of the agenda).
- iii) While noting the follow up action of resolution No. 22 of 76th meeting held on 30.03.2017 in this meeting it was further resolved that marks of research papers be also included alongwith academic merits and experience in uniform criteria of shortlisting candidates adopted by this University. It was further resolved that instead of 20, 25 candidates may be called for 1 (one) post.
- 4. i) While noting the follow up action of resolution No. 4 of 77th meeting held on 18.05.2017, it was further resolved that remuneration/honorarium of Deans of Faculties, Dean Academic Affairs, Dean of Colleges, Dean Alumni, DSW, Proctor & Chief warden be increased to Rs. 3,000/- instead of Rs. 1,000/-.
 - ii) It was further resolved that remuneration/honorarium of Rs. 5,000/- in lumpsum be given to the Secy. to Vice-Chancellor per month in place of existing remuneration Rs. 1,200/- per month.

- iii) The remuneration to the external Members of the Executive Council be increased from Rs. 2,000/- to Rs. 3,000/- for attending the meeting of the Executive Council only and the same be notified by the Accounts Branch.
- iv) The remuneration Rs. 2,000/- each per meeting paid to the outside experts for various Selection Committees of the University be paid Rs. 2,000/- per session and only upto maximum three sessions subject to maximum of Rs. 5,000/- per day.
- 7. While noting the follow up action of resolution No. 7 of 77th meeting held on 18.05.2017, it was further resolved that date of technical resignation be read as 30.08.2013 instead of 30.08.2014.
- 12. While noting the follow up action of resolution No. 12 of 77th meeting held on 18.05.2017, it was further resolved that the proforma devised by the Committee constituted for the purpose for promotion of teachers according to 4th amendment (i.e. 11.07.2016) be circulated among the teachers and same also be uploaded on the University website for inviting objections within 15 days and place the matter in the next meeting of the Executive Council.
- 21. While noting the follow up action of resolution No. 21 of 77th meeting held on 18.05.2017, it was further resolved that the rates of Lab. be revised from Rs. 250/- per Lab. to Rs. 300/- per Lab. subject to maximum of Rs. 1,000/-
- 24. While noting the follow up action of resolution No. 24 of 77th meeting held on 18.05.2017,

The Vice-Chancellor apprised the House that one of the candidates Dr. Ashutosh Mishra, when asked for a proof of API score, refused to provide the proof, rather he said that he may be considered for the interview under the category of Professional (category 'B') where the API score is not required. The bio-data received under the category 'B' of the candidates were already got evaluated by that time from the outside subject experts as per rules. The said candidate was called for interview keeping in mind that his eligibility can be settled at the time of interview.

The interview was conducted under the circumstances of protest from the students for interviewing one of the ineligible candidates for the post of Professor in the Department of Communication Management & Technology. The interview was, however, conducted and recommendations were made presuming that the eligibility has been checked. The recommendations of the Selection Committee were put up before the Executive Council held on 18.05.2017. It was pointed out that there is technical flaw in selection as eligibility has

not been checked by office for API score due to lack of proofs. Eligibility of two other candidates was also questioned by public through newspaper and another candidates who were not called for interview. Though, it was verified from the record that the eligibility of these two candidates has been checked by office, giving benefit of incomplete advertisement. However, there is nothing on the record that shows that the eligibility of Dr. Ashutosh Mishra has been checked by the Selection Committee or by the office before the interview. Since, there are more than one candidate who appeared in interview and whose eligibility has been questioned either due to non-availability of the documents or due to advertisement. The House is requested to take a conscious decision as some technical flaws have taken place due to the circumstances created at the time of interview and non-availability of the required documents in time by the candidate.

The House deliberated and the resolution is as under :-

It is resolved that the post of Professor in the Department of Communication Management & Technology be re-advertised as there are certain technical flaws in the process which led to recommendations of the Selection.
