While noting the action taken report on the decisions of 67<sup>th</sup> Meeting held on 27-03-2014 regarding Resolution No.17, the Executive Council resolved that the deposit work be treated as construction work not a consultancy work and therefore any income arising from this assignment should go to the University Accounts as University income.

Further, while noting the action taken report regarding Resolution No. 20 of 68<sup>th</sup> meeting of Executive Council, it was resolved that copy of the complaints/representations under reference received through office of the Secretary to Governor, Haryana, Chandigarh vide letter No. HRB-UA-2014/1581 dated 04.03.2014 and report of the Committee be placed before the Executive Council for information in its next meeting.

3. Considered the Budget Estimates for the financial year 2015-2016 and Revised Estimates for 2014-2015 of Guru Jambheshwar University of Science & Technology, Hisar.

The Finance Committee considered the above item vide resolution no. 3 of its meeting held on 27.03.2015 and recommended to the Executive Council as under:-

- (i) Budget Estimates for the year 2015-2016 and Revised Estimates 2014-2015 as presented were considered and recommended as such to the Executive Council and Court for approval and noted the grant-in-aid as Rs. 45.00 crores for the year 2015-16.
- (ii) The Committee recommends to authorize the Vice-Chancellor to recast the budget estimates at his own level in the manner he deems it fit to contain the budget estimates within the resources available and the expenditure within the approved Budget Estimate.
- (iii) The committee further resolved that the State Govt. be requested for inclusion of the committed liability of the University into 'Non Plan Scheme' of the State Govt.

Resolved that the above recommendations of the Finance Committee be approved and recommended to the University Court.

The House appreciated the efforts made by the University Authorities in getting grant-in-aid of Rs. 45.00 crores from the State Govt.

The Council further resolved to place on record the gratitude towards the officers of the State Govt. particularly the Department of Finance and Technical Education Haryana for their co-operation and extending liberal financial assistance towards the University.

 Noted the Annual Accounts, Balance Sheet and Annual Audit Report of Guru Jambheshwar University of Science & Technology, Hisar for the year 2013-2014

The Finance Committee considered the above item in its meeting held on 27.03.2015 vide resolution no. 4 and resolved as under:
