The leave</u> <u>period will be excluded from the total</u> <u>lectures delivered during the semester.</u> But, the concerned student has to appear in all the minor/ Major Examinations etc. as per schedule notified by the department/ University. 35. Considered the report of the committee constituted by the Vice-Chancellor to enquire into the matter regarding some allegations imposed on Prof. Milind Parle, Department of Pharmaceutical Sciences.

Resolved that an advise to be careful in future be issued to Prof. Milind Parle and further he should follow the procedure set by the University for conduct of internal examinations.

36. Considered the matter regarding higher starting of pay in pay band to Sh. Partap Singh Malik, Director (Placement) at Rs 43210/- w.e.f. 15.12.2016 i.e. his date of joining in the university which he was drawing at the time of resignation in Centre for development of Telematics, Telecom Technology Centre of Govt. of India.

Resolved that the above proposal be approved. Further in future the candidate(s) be asked to submit Form 16B in this regard.

37. Considered the request of Sh. Mukesh Kumar, Head, University Computer & Informatics Centre to extend the Ph.D completion duration for three years i.e. from 10.06.2017 to 09.06.2020 & to consider grant of annual increments during these three years.

Resolved that the above proposal be approved.

38. Considered the recommendations of the committee with regard to adjustment of teachers appointed under Self Financing Scheme against budgeted posts in a phase manner (Annexure-XLIV Pages 213-214 of the agenda).

Resolved that the recommendations of the Committee at point No. 1 be forwarded to the State Govt. for approval. Further resolved that the recommendations of the Committee at point No. 2 for adjustment of teachers from Sr. No. 1 to 12 under Self Financing Scheme against budgeted posts be approved.

It was also resolved that the Vice-Chancellor be authorized with regard to adjustment of teachers appointed under Self Financing Scheme against budgeted posts in a phase manner continuously.

39. Considered the case of confirmation of Dr. Dharmender Kumar, Associate Professor, Department of Computer Science on the post held by him w.e.f. 27.11.2014 (A.N) on having satisfactorily completed probation period subject to the decision of the Hon'ble Punjab & Haryana High Court, Chandigarh in CWP No.23824 of 2013 – Lalita Vs GJUS&T, Hisar

Resolved that the above proposal be approved.

40. Considered and approve the recommendation of the Committee for revision of remuneration for evaluation/re-evaluation of answer books @ Rs. 25/- per answer book instead of Rs. 15/- subject to minimum of Rs. 250/- instead of Rs. 150/- for all the examinations to be implemented w.e.f. the session May/June 2017 onwards (Annexure- XLV Page 217 of the agenda).

41. Considered the matter for adjustment of one Associate Professor and one Assistant Professor appointed in the UGC-Human Resource Development Centre keeping in view the resolution No. 39 of the Executive Council of its meeting held on 29.12.2015 (Annexure-XLVI Page-219) as well as letter dated 29.03.2017 of the University Grants Commission, New Delhi with regard to continue the existing schemes for the year 2017-18 (Annexure-XLVII Page-220 of the agenda).

Resolved that the University Grants Commission be asked to continue the existing scheme for the year 2017-18 for teachers of HRDC. Further resolved that all the teachers appointed in the UGC-HRDC will be entitled for all the facilities as available to other teachers as per University rules. Further resolved that they be given salary in time by making alternative/temporary arrangements.

42. Considered the request of Mrs. Poonam Devi W/o Late Sh. Mintu, Village –Lalpura, Tehsil- Hansi, Dist- Hisar forwarded by the Deputy Commissioner, Hisar for appointment on the post of Peon, as a special case.

Resolved that the above proposal be approved and the government be requested to convey concurrence on the issue.

43. Considered the matter for finalization of seniority of teachers working in the University Teaching Departments of this University.

Resolved that the above proposal be deferred.

44. Any other item.

Existing Lab Attendants have requested the Vice-Chancellor that some posts of Lab Attendant may be up-graded into Lab Technician to explore the promotion avenues for them. Taking a lenient view on their request, the Vice-Chancellor has discussed the matter in the house. To avoid the stagnation among the existing Lab Attendants, It was resolved by the house that the State Govt. be requested to upgrade the 15 posts of Lab Attendant in Pay Scale of Rs. 5200-20200+1900GP to posts of Lab Technician in Pay Scale of 9300-34800+3600GP
