## 2. Prequalification criteria: scan copy of following documents are required online:

## Eligibility Criteria shall be as follows:

- i. Successfully completion of one work of similar nature (i.e. supply of furniture items) not less than the amount equal to 60% of the estimated cost or two works of similar nature not less than the amount equal to 50% of the estimated cost each or three works of similar nature not less than the amount equal to 40% of the estimated cost during last five years. Weightage for escalation @10% for each completed year will be accounted for the old completed works while working out the cost of similar works. However, no weightage will be given for the works in hand started one year prior to the date of calling of tender.
- ii. (a) The principal manufacturing company shall have ISO 9001:2015 and ISO 14001:2015.
  - (b) SEFA 8M third party test report from the approved lab of SEFA.
  - (c) SEFA Membership required continuous from last 3 years.
- iii. Scan copy of GST registration certificate.
- iv. Scan copy of latest Income Tax return will also be submitted.
- v. Scan copy of PAN will also be submitted.
- vi. In case of dealers/contractors/societies quoting for the tender, authorization certificate to be attached from the manufacturing company confirming that the dealer is authorized to bid for this project and the company will supply the tender items to the bidder within the specified time frame and will also support the bidder in giving after sale service including maintenance and availability of spare parts if needed for the purpose.
- vii. The certificate duly attested by a Chartered Accountant minimum Average Annual financial turnover during the last 3 years, ending 31st March of the previous financial year should be at least 25% of the estimated cost (10% compounded value per year to be added).

- viii. One sample of each items of furniture mentioned in the DNIT must be brought by the contractor/manufacturing company/dealer at the time of opening of technical bid. Sample only be considered of those agencies who will be technically qualified. Financial bid only be opened of those agencies who will qualify the technical bid as well as their sample are approved by the committee. Conditional tenders will not be entertained & are liable to be rejected.
- ix. If any agency/firm/contractor do not quote all items of DNIT, the tender of the same will be treated as cancelled
- 3. Conditional tenders will not be entertained & are liable to be rejected.
- 4. In case the day of opening of tenders happens to be holiday, the tenders will be opened on the next working day. The time and place of receipt of tenders and other conditions will remain unchanged.
- 5. The undersigned reserve the right to reject any tender or all the tenders without assigning any reason.
- 6. The societies shall produce an attested copy of the resolution of the Co-Operative department for the issuance of tenders.
- 7. The tender without earnest money / bid security / tender document fee will not be opened.
- 8. The jurisdiction of court will be at Hisar.
- 9. The tender of the bidder who does not satisfy the qualification criteria in the bid documents are liable to be rejected summarily without assigning any reason and no claim whatsoever on this account will be considered.
- 10. 1% Earnest money or Rs. 25000/- whichever is less upto Rs. 50.00 lakh will be deposited by the Co-Operative Labour and Construction Societies. Further for work beyond Rs. 50.00 lakh, 50% of the earnest money applicable to the contractor will be deposited by the Co-Operative Labour and Construction Societies.
- 11. The bid for the work shall remain open for acceptance during the bid validity period to be reckoned from the last date of **E submission of BS**. If any bidder/render withdraws his bid/tender before the said period or makes any modifications in the terms and conditions of the bid, the earnest money shall stand forfeited. Bids shall be valid for 120 days from the date of bid closing. In case the last day to accept the tender happens to be holiday, validity to accept tender will be the next working day.
