The medical reimbursement for indoor treatment from the above doctors will be admissible in accordance with the rates equal to PGIMER, Chandigarh. It will be


applicable in case of NC Jindal Hospital, Hisar also. There will be no reimbursement of the amount over and above the rates of the PGIMER, Chandigarh.

Since it is a referral medical facility, concerned employee would be required to follow the following procedure:

1. To submit, in duplicate, list of the dependents, alongwith photographs of the dependents latest by 10.12.2009. (Format enclosed).
2. To get the case referred from the University SMO/MO. While seeking such referral, the employee would ensure that a photograph (Self attested) of the patient is also got pasted on the referral slip/letter. In case of hospitalization during holidays, SMO/MO (Mobile No.9416139979, 9416164012) be informed telephonically immediately and the employee should submit a written request, alongwith self-attested photograph of the patient, immediately on the next working day.
3. The validity of such referral case would be only for seven days (including referral date). Thereafter, fresh referral slip is to be obtained from SMO/MO of this University.
4. The referral slip, bearing photograph is also to be got verified from the doctor to whom the case was referred.
5. The reimbursement specific only to the specialty of doctor as approved overleaf would be allowed.

The above arrangements will be effective with immediate effect. Accordingly, the contents of the letter may please be brought to the notice of all the staff member working in your department/office.
