On consequence of extension of schedule of ~~online~~ admission in UG courses conveyed by Director General Higher Education, Haryana vide memo no. DHE-080001/16/2021-IT CELL-DHE dated 24.08.2022 & 31.08.2022, the schedule for online submission of Registration Returns/Continuation return on university web portal of the students admitted in the session 2022-23 for UG courses is further extended as under:

Last Date of admission in UG courses	Normal Last date of submission of online Registration/Continuation Return without fine (1st 20 days from the date of last date of admission) (Last date of admission + 20)	Last date of submission of online Registration/Continuation Return with late fine of Rs.100 per student per day. (21 st day to 40 th day from the date of last date of submission) (Last date of admission + 40 days)	41 st day onward

Arts/Science/ Commerce 05.09.2022	25.09.2022	15.10.2022	No Registration Return will be entertained after 40 days. i.e. after the last date mentioned in previous column (iv). However, the Vice-Chancellor may consider to allow/ to admit the Registration Return/Continuation Return as a special case, with additional fine, keeping in view the genuineness of reasons submitted by the Principal of the college concerned.


