OFFICE ORDER

Solid Waste Management Rules have been implemented in the Country. National Green Tribunal has issued strict instructions for Solid Waste Management. CPCB and HPCB are monitoring the implementation of SWM Rules. The local agency Municipal Corporation, Hisar is also inspecting and ensuring implementation of SWMR. All the Bulk solid waste generators have to manage their generated Solid Waste at their own end. A heavy amount of fine has been imposed on various agencies on the violation of SWMR. The University is under their surveillance. **The first step of Solid Waste Management is to segregate the waste in three separate streams Bio-degradable, Non-Bio-degradable and Domestic Hazards waste.**

All the users/residents are requested to dispose off their waste in segregated form in three streams.

The University waste picker vehicle will arrive in the campus and collect the waste only in segregated form from door to door. Combined waste will not be accepted.

The Solid Waste should be categorized as under:-

- (1) All polythene products should be in **one stream**.
- (2) All the **Bio-degradable** waste such as fruits, Vegetables, spared cooked food and eatable etc should be in **second streams**.
- (3) All **Sanitary Napkin** and such type of other items should be wrapped in wrapper and must not place/dump in any other type of waste. These may be handed over separately to waste pickers.
- (4) All the paper/cardboard should be kept aside from the above.
- (5) All the glass ware may be handed over separately to waste pickers.

All the residents are requested not to place or dump their waste anywhere except waste picker vehicle. All Bio-degradable waste shall be converted into compost by vermicomposting method. All polythene waste will be managed separately.

All Sanitary Napkins and like nature waste will be disposed off as per rules. Any type of E-Waste or Biomedical Waste will not be included in solid waste. On the violation of the above said rules, Municipal Corporation, Hisar team may impose fine as per NGT guidelines.

Segregation of Domestic Waste.

It is suggested that two color dustbins in which Green one for Bio-degradable waste and Red for Non-Bio-degradable may be used for waste and handed over to the waste pickers in two streams. It is also requested that plastic of single use such as **use and throw plastic/thermo-col plates, glasses etc** may not used in the campus. All the residents are requested to cooperate in keeping the campus neat, clean and plastic free campus and to follow the above said instructions.

Cooperation in this regard shall be highly appreciated.
