The online internal assessment awards may be submitted on the portal given by the University for all courses run in the affiliated colleges with this University and the same should be received in the examination branch upto 20 days after the commencement of theory examination. After that the internal assessment will be accepted with a late fee of Rs.200/- per day per course subject to maximum of Rs.1,00,000/- for all courses run in the affiliated colleges/institutes before a day of declaration of result. It is also clarified that after declaration of result no request for acceptance of internal awards will be entertained.
