And, in case late submission i.e. after 30th June, the late fee will be charged as per the following schedule :-

Duration	Powers Vested in	Late Fee as Prescribed from time to time
Upto one month	Controller of Exams.	Rs.200/-
Beyond one month and upto two months.	-do-	Rs.700/-
Beyond two months and upto three months.	Vice-Chancellor	Rs.1200/-
Beyond three months and upto twelve months.	-do-	Rs.3000/-
Beyond twelve months onwards upto the end of duration of course.	-do-	Rs.4000/-


Late fee as prescribed in each case will be chargeable.

"Provided that if a candidate fails to submit the dissertation etc. even during the extended period of three months i.e. 30th September of the year concerned, he/she will be considered to have absented in the dissertation etc. paper and his/her result will be declared accordingly."
